The KING project's objective is to elaborate a report on the **state of play** of migrant integration in Europe through an multidisciplinary approach and to provide decision and policy-makers with **evidence-based recommendations** on the design of migrant integration-related policies and on the way they should be articulated between different policy-making levels of governance.

To this end, a truly multidisciplinary approach has been adopted. Indeed, migrant integration is a multi-faceted process. Thus, the contribution of the insights offered by different disciplines is essential in order better to grasp the various aspects of the presence of migrants in European societies at national and sub-national levels, and, ultimately, the very meaning of integration. The presence of experts from seven different disciplines – EU Law and Policy, Political Science, Public Administration, Social Science, Applied Social Studies, Economics, Demography – ensures the comprehensiveness of the picture concerning migrant integration resulting from the research produced by KING.

The ultimate goal of the KING project is to provide evidence-based policy recommendations on how to govern the manifold aspects of migrant integration at all levels of governance and across the different policy fields in order to fully realize the potential that migration represents for **European societies**.


